

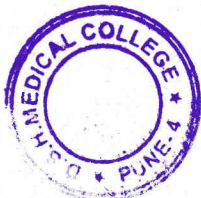

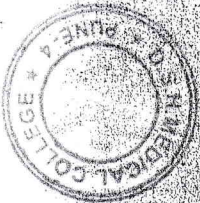
MEMORANDUM OF ASSOCIATION (as amended on 24-5-50 & 26-6-50)

1. Name:
The name of the Society shall be "The Maharashtra Technical Education Society".
2. Head Office:
The Head office of the Society shall be in the Province of Bombay.
3. (A) Aims and objects
 - (a) To create, promote and intensify a desire in Indian youth for technical education, equipment and original research and to provide facilities for such education.
 - (b) To start, maintain and affiliate Schools, Colleges and other Institutions useful in imparting Engineering, Medical, Industrial, Technical and Agricultural Education and also for research in any or all of its branches.
 - (c) To maintain workshops, to start, maintain and affiliate Laboratories, Factories, Hospitals and other Helpful institutions, exclusively for imparting practical Education.
 - (d) To publish books and journals etc. and organise practical courses, lectures, exhibitions, demonstra-

... museums, cinema films, Radio-programmes and other means and ways of diffusion of knowledge.

To aid and organise Post Graduate and other research work in any or all branches of Engineering, Medical, Industrial, Agricultural and Technological Education.

- (B) For the fulfilment of these Objects the Society will endeavour:
 - (a) To collect and disburse Donations, Grants and Funds;
 - (b) To acquire, take on lease, purchase, mortgage, create any charge, sell any movable or immovable property;
 - (c) To purchase, sell, deposit by way of security or otherwise deal with any stock, share, debentures, Government Promissory notes or any other Valuable security and
 - (d) To do all such things as may be necessary to promote the aforesaid aims and objects of the Society.

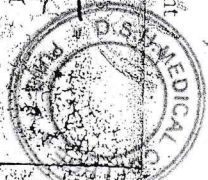

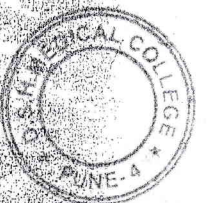

of Control and which (Conditions) do not create any charge or burden on the Society of more than 2½% of the amount in one year shall be recommended to the Board of Control to enlist him as a member of the Society. After such donation is received and Conditions accepted, he can be elected a member of the Society.

IV. Honorary Members

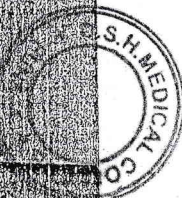
The Board of Control shall have the right to nominate any person as an Honorary Member of the Society in view of his having rendered meritorious services in the cause of Technical Education by a majority of fourfifths of the strength of the Board. He shall hold office for life, unless he resigns. The total number of such Honorary Members shall not exceed eleven at any one time.

4. Management

The management of the Society shall vest in a Board of Control.

5. General Body

- (a) All the members of the Society mentioned in clause 3 above constitute the General Body which shall meet at least once a year in the month of Magh.
- (b) Special or Extra-ordinary meeting of the General Body may be called by the President of the Society whenever necessary as also on a requisition submitted as per rules framed for that purpose.
- (c) Notice of Meetings—Clear fourteen days' notice in writing shall be given to all the members stating the business to be transacted at such meeting.
- (d) Quorum of Meetings—The quorum for a meeting of the General Body shall be eleven.

RULES & REGULATIONS

1. Name

The name of the Society shall be The Maharashtra Technical Education Society

2. Year

The Official year of the Society shall commence with the First day of Kartik and close with the 30th day of Ashwin, (Vikram Samvat)

3. Membership

There shall be four classes of members :

I. Founder Members

Those thirteen who have signed the Memorandum and Articles of Association at the time of Registration of the Society in September 1945.

II. Donors:-

Persons who pay a sum of Rs. 1000/- or more to the Society without any condition for its use shall be recommended to the Board of Control to enlist them as members of the Society.

(This amount can be paid in instalments within a period of two years; After the amount is received, the Board of Control of the Society can elect him as a member by a resolution to that effect.)

III. Endowment Members

Persons who pay to the Society Rs. 10,000/- or more with such conditions as are acceptable to the Board



(b) The Members of the Society including the endowment Members shall elect not more than seven members from amongst themselves.

(c) The teachers or Life-Members of the teaching institutions of the Society shall elect from amongst themselves two to four members to work on the Board of Control. These members will not be more than one-third of the other members.

(d) The members of (a) and (b) class shall nominate one or two members to work at the Board of Control either from the members of the Society or outsiders as experts.

(B) The period of members of the Board of Control will be four years and one-fourth members shall retire every year and the vacant seats will be filled in by election from the members of the class from which the member retires. The Senior Members to retire by rotation.

If a Vacancy is caused the other members will nominate a member for the remaining period of the Vacancy.

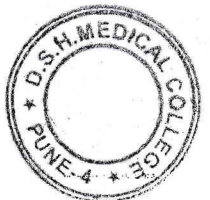
The member so nominated will be from the class of members whose seat is vacant.

(C) The Board shall elect from amongst themselves a Chairman, a Vice-Chairman and a Secretary after every fresh election.

(D) The Board shall meet as often as necessary. It shall call a meeting of the General Body every year in the month of Magh and shall also call an extraordinary meeting of the General Body whenever called upon to do so by the President in his own right or by a requisition submitted as per rules to be framed for that purpose.

(E) It shall submit to the General Body a Report of the progress of the Society every year and have a balance

- (e) The Founder members shall elect a President and one or more Vice-Presidents of the Society. At all meetings of the General Body the President shall preside and in his absence the Chairman of the Board of Control shall do likewise. In the absence of both, the General Body shall elect its own Chairman for the meeting.
- (f) The Secretary of the Board of Control shall also be the Secretary of the Society.

6. The Treasurer

The Treasurer shall be elected by the General Body and shall hold office for a period of three years.

7. The Auditor

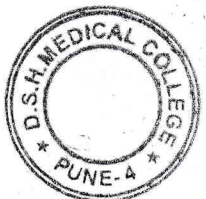
The General Body shall elect an Auditor every year. He shall not be a member of the Board of Control or of any of the Committees, that the General Body or the Board of Control may hereafter appoint. He shall examine, scrutinize and certify the accounts of the Society. The Auditor may be paid such sum for his services as the General Body may decide.

8. The Board of Control

(A) There shall be a Board of Control to whom the whole responsibility of the management and conduct of affairs of the Society is entrusted.

The Board shall not have less than 7 (Seven) members and not more than 15 (fifteen) members, who will be elected as follows:--

- (a) The Founder members shall elect from amongst themselves two members, or if they choose may nominate one or two members from the endowment Members.



11. Bankers

The Bank of Maharashtra, Ltd., Poona, The Imperial Bank of India, Ltd., and such other Banks as may be approved by the Board of Control, from time to time, shall be the Bankers of the Society.

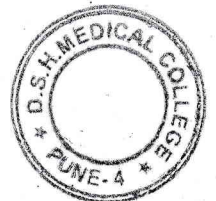

(F) The Board of Control shall be responsible for all the management and financial affairs of the Society.

(G) The Board of Control shall keep or cause to be kept proper accounts, shall collect donations and subscriptions, shall negotiate and accept loans, shall appoint permanent staff and shall recommend members for acceptance to the General Body.

(H) The first Members of the Board of Control shall hold office for a period of seven years and the next succeeding ones shall hold office for a period of ~~three~~ *four* years.

9. General

(a) Any member of the General Body may move amendments to the Report in the meeting of the General Body and may move any other resolution regarding the working of the Society.

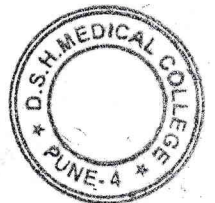
(b) The elections to the Board of Control shall be held in the manner and the method determined by the Board in rules and bye-laws made for that purpose.

(c) No rules so made shall be altered or modified except by a three-fourths majority of the General Body of persons present and voting.

(d) Vacancies—Any vacancy occurring in the Board of Control in the interval of two elections may be filled in by the respective Bodies, for the remaining period.

10. Legal Representative

The Secretary of the Board of Control shall represent the Society in all legal matters.
